

Demographic Trends and Health Conditions




Percentage of people aged 65 and over, Puerto Rico 1960-2030

Top causes of death among the elderly Puerto Rico, 2008

- 1. Diseases of heart
- 2. Malignant neoplasm
- 3. Cerebrovascular diseases
- 4. Chronic lower respiratory diseases
- 5. Alzheimer's disease
- 6. Diabetes mellitus
- 7. Influenza and pneumonia
- 8. Nephritis, nephrotic syndrome and nephrosis
- 9. Intentional self-harm (suicide)

The Right Care

Levels of care include:

- Primary prevention of chronic diseases
 - helping the healthy elderly stay healthy
- Secondary/tertiary prevention
 - minimizing the negative effects of the disease
 - controlling and preventing related complications

Puerto Rico Department of Health interventions/dynamics

- Address all components of care as an integrated system
- Build up prevention of chronic disease efforts
- Reinforce culturally appropriate health education to elders, family members and caregivers
- Increase communications between providers by promoting the use of electronic medical records

The Right Time



Right time is contingent to access to services, that is:

- Availability adequate supply of services and trained professionals
- Affordability health insurance coverage; ability to pay
- Geographical location distance from home; transportation
- Accommodations and acceptability clinic facilities; waiting time; and characteristics of providers

Puerto Rico Department of Health interventions/dynamics

- Reinforce primary care infrastructure by establishing alliances among government clinics, community and private clinics
- Ensure that all eligible seniors are registered for public sponsored health insurance
- Support fellowship programs in Geriatrics and Gerontology
- Examine the role of other public and private agencies in access to healthcare and social support

The Right Place

Right place relates to medical conditions, level of independence and financial status

Services include:

- Assisted living
- Adult day care
- Home care
- Residential home
- Nursing home

- Acute care for the elderly in hospital (ACE)
- Respite care
- Skilled nursing facilities
- Hospice care

Puerto Rico Department of Health interventions/dynamics

- Conduct a complete review of licensure procedures for elderly care facilities
- Promote interdisciplinary teams for adequate care
- Increase access to information on facility licensure status and relevant information for decisions on place of care
