



- On Oct. 31, the first PR-USVI Ocean Economy Workgroup meeting was held
- Participants included federal partners (EDA, FEMA, DOI, NOAA, EPA), local stakeholders from both PR and the USVI (nonprofits, universities, and local government representatives)




## **Hurricane Maria Capacity Building Program**



# **Workforce Projections- Lead Inspection**

The HUD funded CDBG-DR program has set aside several million dollars which will go towards homeowner rehabilitation and reconstruction, rental rehabilitation & reconstruction

All housing units assisted using CDBG-DR funds must comply with the regulations regarding lead-based paint- Lead Poisoning Prevention in Certain Residential Structures.

Need for certified lead-paint inspector (certified under a Certification Programs)

Requirement to determine how many certified inspectors would be needed


# **Workforce Projections- Mold Remediation**

PR and the USVI are located in a tropical climate, that make buildings more vulnerable to mold exposure

- Since the 2017 Hurricanes, several schools and hospitals have had major portions of the facilities closed off due to mold infestation and have not yet been remediated for reconstruction.
- Consistent mold exposure can affect the immune system and trigger chronic headaches.

Therefore, it is critical to determine the how many certified mold remediation experts in PR and the USVI are needed.
