Small Business Pulse Survey Updates

Based on responses collected **September 6 through September 12**, the Small Business Pulse Survey estimates that:

• 44.5% of U.S. small businesses have experienced a moderate negative effect from the COVID19 pandemic

- 43.9% of U.S. small businesses believe more than 6 months of time will pass before their business returns to its normal level of operations
- **55.0%** of U.S. small businesses did not furlough or lay off any paid employees after March 13, 2020
- 60.5% of U.S. small businesses experienced no change in operating revenues in the last week
- 61.1% of U.S. educational services businesses have experienced an increase in the use of online platforms to offer goods or services since March 13, 2020
- 48.2% of U.S. retail trade businesses have experienced domestic supplier delays in the last week
- 82.1% of small businesses in Tampa-St. Petersburg-Clearwater, FL Metro Stat Area received financial assistance from the Paycheck Protection Program
- 26.2% of small businesses in the Oklahoma City, OK Metro Statistical Area have had little or no effect caused by the Coronavirus pandemic on their business

Household Pulse Survey

The U.S. Census Bureau resumed data collection for the second phase of the experimental Household Pulse Survey August 19. Biweekly results will be available through the Household Pulse Survey Interactive Tool, detailed tables and a public use data file on the website from September 9 through November 4, 2020. This is the off week for data reporting.

Phase 2 includes new questions on social security benefits, postsecondary education, evictions/foreclosures, SNAP benefits, unemployment benefits and mental health services.
