Distance Learning and Telemedicine Grant Program_USDA Rural Development is making grants available to help rural communities use the unique capabilities of telecommunications to connect to each other and to the world, overcoming the effects of remoteness and low population density. **Application Deadline: July 13, 2020, via** Grants.gov

Business and Industry (B&I) CARES Act Program_USDA is making available up to \$1 billion in loan guarantees to help rural businesses meet their working capital needs during the coronavirus pandemic. Additionally, agricultural producers that are not eligible for USDA Farm Service Agency loans may receive funding under USDA B&I CARES Act Program provisions included in the Coronavirus Aid, Relief, and Economic Security (CARES) Act. Application Deadline: September 15, 2021, or until funds are expended

Renewable Energy Systems and Energy Efficiency Improvements (Rural Energy for America Program) The REAP program will provide funds to agricultural producers and rural small businesses to install renewable energy systems and energy efficiency improvements. Application Deadline:

Open Rural Digital Opportunity Fund The Federal Communications Commission is providing funding to bring high-speed, fixed broadband service to rural homes and small businesses that lack access. Application Deadline: October 22, 2020 Community Facilities Direct Loan & Grant Program USDA Rural Development is making funding available to build, expand and improve essential community facilities, which includes qualified equipment. Capacity Building Developmental & Capacity Building Grant_This U.S. Department of Labor grant is intended to develop and conduct training and educational programs for small businesses on occupational safety. Application Deadline: July 20, 2020

Rural Cooperative Development Grant Program USDA Rural Development is making grants available to help start, expand or improve rural cooperatives and other mutually-owned businesses in rural America. Application Deadline: August 3, 2020

Agriculture and Food Research Initiative – Education and Workforce Development This USDA National Institute of Food and Agriculture program is making grants available to support professional development for agricultural literacy, training for research and extension undergraduate students, fellowships for predoctoral candidates, fellowships for postdoctoral scholars, and training for the agricultural workforce.
